RE: SPECIAL ELECTION COSTS - Measure B Alameda Point Development Initiative

Dear Mr. Faye:

On February 2, 2010, the SunCal-sponsored Alameda Point Development Initiative Special Election was held, pursuant to City Council action of November 3, 2009, setting the date and time of the election. Attached, for your review, is a breakdown of expenses for said election in the amount of \$279,629.61.

During various negotiation meetings last fall, payment for this special election was discussed with the SunCal negotiation team, but the City received no final confirmation that SunCal would reimburse the City for these costs. The purpose of this correspondence is to request SunCal's final decision in this regard.

Please advise at your earliest convenience, as the City processes its invoices Net 30, and I will need to make certain operational decisions by June 30, 2010 if the City is to bear full financial burden for this expenditure.


